We are a 501c3 tax exempt organization; our tax id # is 58-1970404. We are supported largely through Churches, Sunday School Classes and individual Christians who love life and share our vision of the centrality of the gospel of Jesus Christ, the profitability of Biblical values and virtues, and the sanctity of life as it is created in the image and likeness of God.

We are supervised by an Executive Director who answers to our Board of Directors which sets policy and supervised the Director (see more detailed information on the By-Laws).

We have been supported by a multitude of denominational persuasions: Baptist, Methodist, Pentecostal, Catholic, Anglican, Independent, Non-Denominational, Multi-Denominational and Others. We are a Member supported ministry and each year as required by our By-Laws (see attached); we have an annual meeting which consists of established and accepted Church liaisons who represent our Church supporters (members).

We are not able to accept volunteers who can not sign our "Statement of Faith" and generally articulate and demonstrate, via our application process, a commitment to these truths, and to a reasonable continuity of involvement in the fellowship of believers (the Church). We are not able to welcome volunteers from religious sects who misrepresent the true Biblical essence of the Hypo-Static Union (the humanity and Deity of Jesus Christ), the Trinity (Father, Son, and Holy Spirit-one in nature,

three in persons), and the true Gospel that Jesus Christ is the way, truth and life and that we experience a relationship with the true God only through faith in His person and work.

We strive neither to be legalistic, nor anti-nomian (lawless); we pray for wisdom from above to represent God faithfully according to His Word.
